II. Approval of the Minutes.

Approval of the Minutes of the Regular Meeting of February 24, 2020.

On a motion by Mayor pro tem Powers, second by Commissioner Dusenbury; and, all voting “aye,” the minutes of the Regular Meeting of February 24, 2020 were approved as recommended.
