On a motion by Mayor pro tem Powers; second by Commissioner Dusenbury; and, all voting “aye,” the minutes were adopted.

V. Agenda Action Items.

A. Appointment of Police Chief.

Recommend confirmation of Scott Richards as Police Chief.

On a motion by Mayor pro tem Powers; second by Commissioner Walsh; and, all voting “aye,” Scott Richards was confirmed as Police Chief.

B. Legacy South Housing Village.

Recommend adoption of Resolution R-22-11 approving design and development components for the Legacy South Housing Village, committing funds for project infrastructure improvements and ensuring the long-term affordability of the housing.

On a motion by Commissioner Mayer; second by Mayor pro tem Powers; and, all voting “aye,” Resolution R-22-11 was adopted as recommended.

C. Police-Mental Health Collaboration Agreement.

Recommend authorizing City Manager to enter into an agreement with View Point Health and approving annual budget in the amount of \$84,000.

On a motion by Commissioner Mayer; second by Commissioner Dusenbury; and, all voting “aye,” the agreement and budget were authorized as recommended.

D. Georgia Power Easement at McKoy Park.

Recommend approval of an easement to allow Georgia Power to install underground cable in McKoy Park.

On a motion by Mayor pro tem Powers; second by Commissioner Walsh; and, all voting “aye,” the easement was granted.

E. Oakhurst Recreation Center.

- a. Recommend establishment of a project budget in the amount of \$43,000 and award of a contract in the amount of \$41,732.19 to Mohawk Carpet Distribution, Inc. for flooring at Oakhurst Recreation Center.

On a motion by Commissioner Walsh; second by Mayor pro tem Powers; and, all voting “aye,” the project budget and contract award were approved as recommended.

- b. Recommend establishment of a project budget in the amount of \$62,000 and award of a contract in the amount of \$55,775.73 to Atlanta Office Furniture for furniture at Oakhurst Recreation Center.

On a motion by Mayor pro tem Powers; second by Commissioner Dusenbury; and, all voting “aye,” the project budget and contract award were approved as recommended.
