Approval of the Minutes of the Regular Meeting of May 6, 2024.

On a motion Mayor pro tem Powers; second by Commissioner Walsh; and, all voting "aye," the minutes were approved.

## V. Planning Commission Recommendations.

A. The Community & Economic Development Department is requesting text amendments to Article 6 of the Unified Development Ordinance to clarify the utility services and meters between main buildings and accessory buildings/ dwellings. **The Planning Commission recommends approval.** 

On a motion by Mayor pro tem Powers; second by Commissioner Dusensbury; and, all voting "aye" on a roll call vote, Ordinance O-24-Z-04 amending Article 6 of the Unified Development Ordinance was adopted.

B. The Community & Economic Development Department is requesting text amendments to Article 6, 7, and 12 of the Unified Development Ordinance to define the use of short-term rentals and provide associated regulation and permitting standards. **The Planning Commission recommends approval with amendments.** 

On a motion by Commissioner Dusenbury; second by Mayor pro tem Power; and, all voting "aye" on a roll call vote, Ordinance O-24-Z-05 amending Article 6, 7 and 12 of the Unified Development Ordinance was adopted.

C. The Community & Economic Development Department is requesting text amendments to Article 6 and 12 of the Unified Development Ordinance to define the use of smoke, vape, and tobacco shops and provide associated regulation and permitting standards. **The Planning Commission recommends approval.** 

On a motion by Mayor pro tem Powers; second by Commissioner Dusenbury; and, all voting "aye" on a roll call vote, Ordinance O-24-Z-06 amending Article 6 and 12 of the Unified Development Ordinance was adopted.

## VII. Agenda Action Items.

A. Text Amendments-Chapter 94, Article III-Hotel Motel Excise Tax
Recommend adoption of Ordinance O-24-02 amending Section 94, Article III of the
Code of Ordinances for collection of hotel/motel excise tax on short term rentals.

On a motion by Commissioner Dusenbury; second by Mayor pro tem Powers; and, all voting "aye" on a roll call vote, Ordinance O-24-02 was adopted.

- B. Adoption of Tentative 2024 Millage Rates.
  - 1. Ordinance O-24-03 tentatively establishes the General Fund tax rate.
  - 2. Ordinance O-24-04 tentatively establishes the Bond Fund tax rate.
  - 3. Ordinance O-24-05 tentatively establishes the Downtown Development Authority Fund tax rate.

On a motion by Mayor pro tem Powers; second by Commissioner Dusenbury; and, all voting "aye" on a roll call vote, Ordinance O-24-03 tentatively establishing the General Fund tax rate at 10.64 mills was adopted.

On a motion by Mayor pro tem Powers; second by Commissioner Dusenbury; and, all voting "aye" on a roll call vote, Ordinance O-24-04 tentatively establishing the Bond Fund tax rate at 1.98 mills was adopted.

On a motion by Mayor pro tem Powers; second by Commissioner Dusenbury; and, all voting "aye" on a roll call vote, Ordinance O-24-05 tentatively establishing the Downtown Development Authority tax rate at 0.35 mills was adopted.

C. Conveyance of Wilson Center to Board of Education.

Recommendation adoption of Resolution R-24-04 authorizing the execution of necessary documents to convey to the Board of Education the Elizabeth Wilson School Support Center.

On a motion by Mayor pro tem Powers; second by Commissioner Mayer; and, all voting "aye," Resolution R-24-04 was adopted.

D. Playground Improvement Recommendations.

Recommend adoption of recommendations from the Child Friendly Cities Initiative (CFCI) team for playground improvements to improve accessibility and inclusivity of city playgrounds.

On a motion by Commissioner Walsh; second by Mayor pro tem Powers; and, all voting "aye," the recommendations were adopted as presented.

E. Change Order-Atlanta Avenue Railroad Crossing/West Howard Avenue Traffic Calming Recommend approval of a change order in the amount of \$225,000 and an increase in the contract to \$1,040,000 with Landis Evans & Partners for design services for the Atlanta Avenue Railroad Crossing/West Howard Avenue traffic calming improvements.

On a motion by Commissioner Mayer; second by Mayor pro tem Powers; and, all voting "aye," the change order and increase in contract amount were approved.
