


Decatur adopts a new strategic plan for the next 10 years

In ten years, I expect to see a vibrant and thriving Decatur that has also restored and preserved its diversity and made good on its promises of inclusion."



National Citizen Survey 2020


Government Scorecard: How Are We Doing? (percent responding excellent or good)

DECATUR HAS A PLAN

In fall of 2021, the Decatur City Commission adopted the 2020 Strategic Plan – Destination: 2030



Decatur's Strategic Plan guides City government at the highest level by providing direction on policies and actions to bring the community's vision for its future to life and serves as the foundation for Decatur's annual budget. The new plan sets the foundation for the city to take bold action over the next 10 years that will make our community greater and leave a legacy for years to come.

The plan includes six themes: **Equity & Racial Justice**, **Climate Action**, **Civic Trust**, **Affordable Housing**, **Mobility**, and **Economic Growth**, and **five mission statements**.

RACIAL EQUITY STAND, ADOPTED 2021

The City of Decatur is an organization that embraces diversity, equity and inclusion with clear intentional actions in order to dismantle systemic racism and bias. We commit to proactively listen, learn and act to promote equitable outcomes and to cultivate a culture where everyone feels heard, welcome and valued. We accept this responsibility and pledge to hold ourselves accountable for our actions.

Art for the People

In September, the city unveiled the first installment of the Art for the People project with "What Sonia Said," a sculpture by Ellex Swavoni, commissioned to provide representation of Black and Indigenous imagery in public art in Decatur. The project is directed by the Beacon Hill Black Alliance for Human Rights.



EQUITY & RACIAL JUSTICE

Anti-Racism Speaker Series

During the 2021 Anti-Racism Speaker Series, the Better Together Advisory Board engaged community leaders, city officials, and activists on the topic of trust. The conversations explored the trust deficit in our communities, how it impacts race relations, and how we can deepen collaborative relationships and trust throughout the city of Decatur.

The Board kicked off the series with a virtual conversation with Kimberly Jones and Gilly Segal, local authors of *I'm Not Dying with You Tonight*, about prejudice and the racial tension that exists in our country. Part two of the series included a panel discussion with representatives from the Decatur Police Department and the City Schools of Decatur in conversation with the Beacon Hill Black Alliance and two Decatur High School student leaders, creating a space for an honest dialog about trust as the foundation for constructive and purposeful civic engagement and institutional responsiveness. The 2021 series concluded with a discussion on coalition building, community engagement, and establishing trusting relationships with Robin Rues Simmons.

The Anti-Racism Speaker series was designed to generate awareness of equity concerns in the city and to hold the city accountable for meeting established goals and implementing policies to achieve the aspiration of being an inclusive, equitable and just city. BEACON HILL CONCERT SERIES

In March, the Beacon Hill Black Alliance for Human Rights, in collaboration with the City of Decatur, held its inaugural concert event on March 27 with a performance by John Boy & Surround Sound that energized the crowd and brought many attendees to their feet. The concerts, which feature live music by Black and indigenous artists, are inspired by Beacon Hill elders as a forum for sharing memories, celebrating the historic Beacon Hill neighborhood, and bringing together the community.

Welcome New Businesses

DECATUR RETAIL

Decatur welcomed **London Bridge Academy of Excellence** as a new business in July 2021. London Bridge offers tutoring services for ages 5-13, and part-time preschool services for ages 3-5, conducted by a licensed teacher with more than 10 years' experience. The academy is at 431 W. Ponce de Leon Ave., Suite 7.

Boho115, a breezy, multi-level restaurant serving up ceviches, fresh fish, sashimis, tostadas and tacos, Argentinian steak and empanadas, opened on the downtown square this spring. Notable on the menu is "conservas," fresh caught seafood hand-packed in tins in Spain and Portugal. The restaurant is at 115 Sycamore St. on the square.



The Decatur Downtown Development Authority selected three businesses, ABETTERBUZZ Brand Goods, Dope Coffee Company and Royal Thanaka Natural Skincare, as part of its inaugural retail recruitment incubator. The incubator provided these online-only businesses with the opportunity to test their concepts in a brick-andmortar location at 431 W. Ponce de Leon Ave., for six months.

HOMELESSNESS Town Hall



The City of Decatur hosted a virtual town hall to discuss homelessness in our community. Participants had the opportunity to engage with experts who have lived experience with homelessness and homeless outreach. The intent was to learn about misconceptions surrounding homelessness, receive updates on the city's current initiatives, and to provide direct feedback to city representatives.

In 2020, the city expanded its crossdepartmental in-house homelessness task team. The team continues to meet, discuss issues, and conduct research with a variety of people, including individuals experiencing homelessness, outreach organizations, and service providers.

Partnering with Frontline Response (formerly known as Atlanta Dream Center), the city continues to connect community members experiencing homelessness with consistent and trauma-informed case management. Since welcoming their new Director of Homelessness in August, Frontline Response has provided case management to 46 individuals and has placed 11 individuals in shelters and housing programs. Still, more work lies ahead as the city continues to take steps toward preventing and ending homelessness.

AFFORDABLE HOUSING

"Missing Middle" conversations

Since hosting the Affordable Housing Summit in 2018, Decatur has been working to collect public input and develop programs to address the lack of housing diversity in Decatur. In 2019, the City assembled the Affordable Housing Task Force, comprised of community members, to present recommendations that were incorporated into the 2020 Decatur Strategic Plan.

As the City moves forward with these initiatives, the next step is housing policy reform to re-introduce the "missing middle" housing types once so prevalent in Decatur's neighborhoods. The first phase of this housing policy initiative included three virtual community-focused conversations, an online survey, storymap, video, postcards, and a hotline to call to ask questions and provide input.

The second phase of public engagement for the City's Affordable Housing Policy includes soliciting additional input from the community. Visit decaturga.com/affordablehousing by July 31, to learn more about initiatives and to submit questions online. The City's affordable housing fellow Kristin Allin is available to speak to neighborhood groups and organizations who want to learn more in a smaller, in-person setting. Questions from the community will be compiled for discussion by a panel at the Affordable Housing Forum on Aug. 17. These questions and input will help finalize the recommendations to the Decatur City Commission as they consider housing policy changes to the Unified Development Ordinance.

New Programs for Housing Affordability

In July 2021, the Decatur Land Trust (DLT) was incorporated as a non-profit entity to facilitate the purchase and development of homes, rental units,

In March, Decatur Land Trust launched two new programs for housing affordability. As part of Decatur's new Housing Affordability program, DLT opened the application process for the purchase of three new residences to City Schools of Decatur, City of Decatur, and Decatur Housing Authority employees. The properties are located within the Park 108 Residences, a redevelopment project by Toll Brothers, located at the intersection of East Lake Drive and Park Place. The new Park 108 community will offer 33 modern condominiums within a historic 1930s Oakhurst building that features oversized windows, lofted ceilings, and wide-plank hardwood flooring. These new residences are zoned for City Schools of Decatur with convenient access to MARTA's East Lake station. Two residences are efficiency (studio), and one residence is a one-bedroom unit. Income restrictions will apply, and buyers must meet lending requirements.

DLT is also accepting statements of interest from Decatur homeowners who wish to apply for the new Decatur Home ReHAB program. Developed to help preserve existing homes for low-income and legacy residents, the program assists with deferred home maintenance projects. CLIMATE ACTION

Clean Energy Plan

In October, the City of Decatur launched Clean Energy Decatur, an initiative to develop a plan for a clean energy future. A series of recorded educational sessions led by subject matter experts on clean energy in Decatur and metro-Atlanta were released throughout the fall and winter to provide a better understanding of the Decatur energy landscape and inform the topics discussed in roundtables. As part of an ongoing effort to protect the city and community from the negative impacts of climate change, Decatur is creating a Clean Energy Plan to help us move away from reliance on fossil fuels and toward a resilient, renewable future.

The Clean Energy Plan is an element of Decatur's 2020 Strategic Plan, Destination: 2030, which identifies climate action, racial equity, and enhanced mobility as top community priorities. Supported by Southface Institute and Greenlink Analytics, the City hosted a series of outreach and educational events to align the Clean Energy Plan with Decatur's values and priorities. While our electricity provider, Georgia Power, will add more renewable energy to its portfolio in the years to come, their current plans only have them increasing from their current 7 percent in 2021 up to 24 percent renewables by 2035. This would leave the remaining balance of 76 percent coming from nonrenewable energy sources like coal, natural gas, and nuclear power.

Mapping Decatur's Urban Heat Island

In May, the City of Decatur began installing a network of temperature and humidity sensors to help study and better understand the local urban heat island effect. The sensors will be located near parks, schools, and along pedestrian and cyclist routes, and will measure the increase in evening temperatures caused by the accumulation of heat-trapping materials like asphalt. The City will use the data to develop plans for minimizing urban heat islands across the city and creating a cooler, more comfortable Decatur. Tree Ordinance

The city revised its Tree Canopy Conservation Ordinance in January, which included an increase in the citywide tree canopy goal to 65%. A second arborist position was added mid-year to the Public Works Department roster to assist property owners and the city in achieving its tree-related goals. A multi-year invasive plant removal project at Legacy Park is already underway with assistance from the experts at Trees Atlanta.

Decatur Receives Silver-level Bicycle Friendly Community Designation

OBLETY

The League of American Bicyclists honored the efforts of City of Decatur to build better places for people to bike with a Silverlevel Bicycle Friendly Community (BFC) award. Decatur joins 497 communities across the country in the movement for safer streets and better bicycling for everyone. The award recognizes Decatur for its commitment to creating transportation and recreational resources that benefit its residents of all ages and abilities while encouraging healthier and more sustainable transportation choices. Decatur is the first Silver-level Bicycle Friendly Community in Georgia.

The League of American Bicyclists' Bicycle Friendly America program sets the standard for how communities build and benchmark progress toward making biking better. The Silver-level BFC award recognizes Decatur's commitment to improving conditions for all people who bike through investments in bike education programs, regular bike events that promote and encourage people to choose biking, pro-bike policies, and bike infrastructure.

The five levels of the BFC award – diamond, platinum, gold, silver and bronze, plus an honorable mention category – provide a clear incentive for communities to continuously improve. Awarded communities must renew their status every four years to ensure that they not only maintain existing efforts, but also keep up with changing technology, national safety standards, and community-driven best practices.

Scott Richards Appointed as New Police Chief

In April, the Decatur City Commission confirmed the appointment of Scott Richards as the Police Chief for the City of Decatur.

Chief Richards began his career as a police officer with the City of Decatur in 1994 and has served with distinction in various capacities throughout his tenure. He served as Deputy



Police Chief starting in 2016 prior to being appointed Interim Police Chief in April 2021. Chief Richards received a Bachelor of Science degree in Criminal Justice from Georgia State University and a Master of Public Safety Administration from Columbus State University.

The City initiated an extensive national recruitment process upon the retirement of former Police Chief Mike Booker who served in that position for 15 years.

Voice of the People

National Research Center (NRC) at Polco and the International City and County Management Association (ICMA) have announced Decatur, Georgia, as the winner of the Voice of the People (VOP) awards for Excellence in Inclusivity/Engagement. The VOP awards are the only national awards that honor local governments based on feedback from residents. The award was presented to City Manager Andrea Arnold and City Clerk Meredith Roark.

Decatur's award recognizes its exceptionally high ratings on the National Community Survey (the NCS) and its intentional, data-informed decisions.





Decatur Wine Festival Returned

The Decatur Wine Festival, Decatur Arts Alliance's largest fundraising event, returned to the square in Decatur in November. More than 500 wines from around the world were available for tasting, a DJ was on site to keep the tunes spinning, local restaurants sold food inside the festival, and chalk artist Jessi Queen created chalk art. The Decatur Arts Alliance provides free annual festivals and events, exhibitions, and outdoor art installations.
